These numbers represent a 5% increase since the start of TCA's fiscal year, 10/1/2022. Zander reported on the record engagement with TCA's awards and image programs and the success of Onwrd & Upwrd, the new PR firm. Zander also provided an update on TPP. There was a review of the new members since the last meeting as well as a review of current prospects. Zander went over upcoming events - Safety & Security and Refrigerated.
